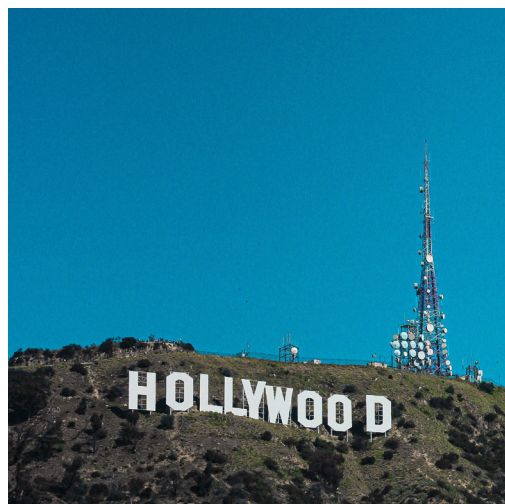

MESSAGE FROM CHAIRMAN



尊敬的会员朋友们：

2019 年是中美建交 40 周年。虽然中美双边经贸关系面临复杂深刻的变化，但经过多年发展，两国经济利益高度融合，各领域交往日益密切，共同应对全球性挑战的需要不断上升。2019 年，受中美贸易战不断升级的影响，双边贸易及中国对美直接投资大幅缩减，但在美中资企业继续克服困难努力发展业务，为美国社区创造经济价值、增加对华出口，并直接和间接支持了美国数百万个就业岗位。同时，各个行业的美国企业积极寻求进一步开拓中国市场，并认为在不断扩大的中国市场中存在重要机遇。2020 年初第一阶段经贸合作协议的签署，有效缓解两国贸易紧张局势，提振了市场信心，向全世界释放出积极的信号。

作为代表中国在美投资企业的规模最大、最有影响力的非营利组织，总商会旨在为中美企业创造价值、推动经济发展、促进中美两国的商业交流与合作。总商会目前拥有约 1500 家会员企业，其中，中资会员企业对美投资额累计超过 1230 亿美元，在美直接雇佣员工超过 22 万人，间接支持超过一百万个工作岗位。2019 年，总商会在全美范

国内举办了百余场活动，加强了政府与企业之间对话，以及中美各方交流合作机制。为了进一步完善会员服务内容，总商会全面升级“中美商业社区生态圈”，发挥平台优势，总商会在官方网站 (www.cgccusa.org) 持续推出相关报告和出版物以及独家的“中美投资合作数据库”，为会员提供有价值的信息。

Dear members and friends,

2019 marks the 40th anniversary of the establishment of diplomatic relations between China and the United States. Although the bilateral economic and trade relations between the two countries have recently faced complex and profound changes, their economic interests have been highly integrated and exchanges in various fields have become increasingly close after years of development. In the same vein, the needs of jointly fighting global challenges has continued to rise. In 2019, despite a decrease of new Chinese investment into the U.S. and the bilateral trade, Chinese companies established in the U.S. continue to grow their businesses, generate value for the U.S. economy and the local community, increase exports to China, and directly and indirectly support millions of jobs throughout the country. Concurrently, U.S. companies seeking further access to Chinese markets in virtually every industry have increased their investments both locally and abroad and have succeeded in benefiting from China's unprecedented economic transformation and the massive growing consumer class. The signing of the China – U.S. phase one trade agreement effectively eased the trade tensions between the two countries, boosted market confidence, and sent a positive signal to the entire world.

As the largest non-profit organization representing Chinese enterprises in the U.S., the China General Chamber of Commerce – USA (CGCC) aims to create value, generate economic growth, and enhance cooperation between U.S. and Chinese business communities. We proudly serve 1500 member companies, in which the Chinese member companies have collectively invested more than \$120 billion in the U.S. and that directly employ more than 200,000 people and support over one million job throughout the U.S. In 2019, CGCC sponsored and cohosted numerous corporate events, increased the level and substance of dialogue between government and businesses, and expanded services to

our Chinese and U.S. members. CGCC's website (www.cgccusa.org) leverages its unique resources by providing valuable information, reports and publications, combined with a proprietary U.S.-China Investment Cooperation Database.

The U.S.-China economic and trade relations affect the world economy. It is beneficial for both countries, as well as the globe to ease the U.S.-China trade tensions. Nevertheless, CGCC's focus has always been on the big picture. Our goal is to ensure that accurate and up to date information is made available to parties at every level of government and business. We believe the two countries will manage differences with mutual respect, expand cooperation based on mutual benefits and reach constructive agreements through pragmatic and sincere negotiations.

It is our hope that this publication will continue to act as a valuable source for people to better understand Chinese companies investing in the U.S. and the real value that investment from China brings to U.S. companies, workers, consumers and local communities. It is my belief that while challenges and disagreements will arise from time to time, enhancing the dialogue and mutual understanding with the principle of seeking common ground while shelving differences will always benefit the businesses and people of both nations.

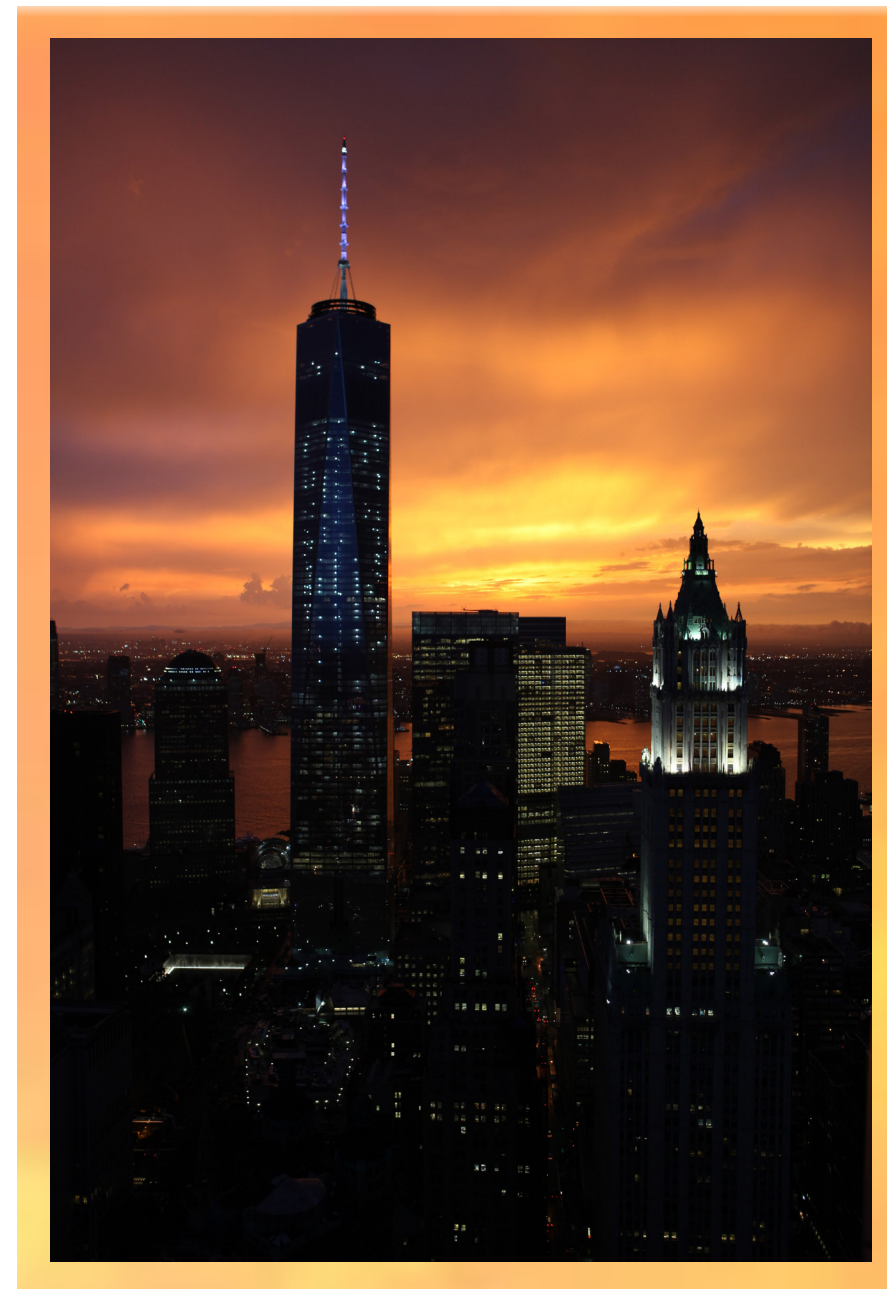

国际律师事务所美富发布了《2019 年度并购报告》，回顾了 2019 年全球并购活动的发展亮点，并探讨 2020 年的重要发展趋势。2019 年全球并购业务依然表现强劲，股票市场虽然经历起伏，但却屡创新高；私募股权公司的融资额打破纪录；各家公司纷纷寻求增长以及解决技术和其他干扰问题的方法。2020 年最大的挑战将是影响整个并购市场的地缘政治和宏观经济因素，包括可能出现的经济下滑、2020 年美国大选，以及中美贸易争端。尽管如此，我们仍预期私募股权发起人将保持活跃，并继续寻求机会以创造性的方式来部署其创纪录的资本。

Morrison & Foerster, a leading global law firm, released its M&A 2019 Annual Review, which reviewed some of the developments arising from 2019's M&A activity, and considered the key trends in 2020. Global M&A made another strong showing in 2019, as stock markets, while at times bumpy, rose to new highs, private equity firms raised record funds, and companies searched for growth and ways to address technological and other disruptions. The biggest challenges in 2020 will be the geopolitical and macroeconomic factors affecting the overall M&A market, including potential economic downturns, the 2020 U.S. elections, and the U.S.-China trade dispute. Nevertheless, we expect private equity sponsors to remain active and to continue to look for opportunities to deploy their record-breaking capital in creative ways.

In February, it was announced that King & Wood Mallesons U.S. advised on Horizon Robotics, a Chinese AI semiconductor unicorn's massive \$600 million Series B funding raising. After this transaction, the company took its valuation to \$3 billion. This was one of the largest investment cases in artificial intelligence for automobile companies.

中国电信 CHINA TELECOM

2月1日，中国电信发起并投资建设的新跨太平洋海底光缆（NCP海缆）在中国上海崇明登陆站业务全线开通。中国电信初期在NCP海缆上海崇明站点亮容量1.5Tb/s，是目前中美之间最大的直达海缆通道。NCP海缆业务的开通，将为中国电信带来近14Tb/s的亚太通信能力，大幅提升中国电信在亚美、亚太地区的网络互联互通能力，确保更强的国际网络健壮性，加速全球数字经济的有效发展。

On February 1, the Chongming, Shanghai landing station of the “New Cross Pacific” submarine optical cable (NCP Cable) was officially activated. China Telecom was heavily involved in the initial planning, investing and construction of this new cable system. China Telecom's initial capacity of 1.5 Tb/s at the Chongming landing station is currently the largest direct submarine cable channel between China and the United States. NCP Cable's activation will bring China Telecom's Asian-Pacific capacity to approximately 14 Tb/s, greatly enhancing China Telecom's network interconnectivity in Asia, America, and the Pacific region, ensuring a more robust international network and accelerating the effective development the global digital economy.

2月，洛杉矶市长 Garcetti、Eli Broad 和建筑师盖里 Frank Gehry 和瑞联集团一起为 The Grand 的正式动工奠基。The Grand 位于布罗德博物馆、迪斯尼音乐厅、科尔本音乐学院和当代艺术博物馆的中心，旨在成为购物、餐饮和娱乐以及范式转换的动态目的地居住地。The Grand 将包括超过 176,000 平方英尺的零售空间，这些零售空间将由大厨主导的餐厅和一系列商店为主。除此之外，还将包括一座电影院大楼；一家 Equinox 酒店®，以及 400 多套豪华住宅，其中 20% 将是政府保障性住房。该开发项目还将包括一个充满活力的大型公共广场以及一系列具有景观美化的开放式露台。

In February, Los Angeles Mayor Garcetti, Eli Broad, and architect Frank Gehry joined Related Companies for the official groundbreaking of The Grand. The Grand will include over 176,000 square feet of retail space anchored by chef-driven restaurants and a collection of shops; a movie theater complex; an Equinox Hotel®; and more than 400 luxury residences, 20% of which will be affordable rate units. The development will also include a large, vibrant public plaza with a series of landscaped open terraces.

On Feb 11, Dominic Ng, Chairman and CEO of East West Bancorp, rang the opening bell at the Nasdaq Stock Exchange in Times Square to celebrate the Bancorp's 20-year anniversary as a publicly traded company. Since the Bank went public in 1999, its assets have grown 1950 percent and net earnings have grown 3800 percent. The bank's footprint also has increased from 23 branches in California to over 125 locations throughout the U.S., including here in New York and in Greater China. With a commercial banking license in China, East West Bank is uniquely positioned among regional banks to serve cross-border companies, providing knowledge and expertise essential to conducting business in both markets. In 2019, East West Bank was ranked in the top 10 in Forbes America's Best Banks for the sixth time, and it has been ranked consistently within the top 15 since 2010.



Greenland USA

2月27日，绿地美国公司完成B12&B13地块成交金额1.43亿美元。TF Cornerstone 向绿地美国支付1.43亿美元，用于购买两个太平洋公园开发用地，TF Cornerstone 主要因其在曼哈顿和皇后区的开发而闻名，计划在改地块上建造两栋共800套公寓、零售租赁以及200,000平方英尺的开放空间。在地块完成交割后，绿地美国于2019年的10月30日对长岛铁路对该地块享有的使用权完成了清除工作，并于同日完成场地清空并移交TF Cornerstone

On Feb 27, TF Cornerstone paid Greenland Forest City \$143 million to purchase two Pacific Park development sites. The deal for B12 and B13 recently closed, the developer, known primarily for its developments in Manhattan and Queens plans to build two towers with 800 apartments and retail, as well as over 70,000 square feet of open space. With the deal being closed, Greenland USA worked with MTA and LIRR terminated and released site storage and parking easement by October 30th, 2019. Greenland USA also completed the site clearance and turned the site over to TF Cornerstone by the same day.

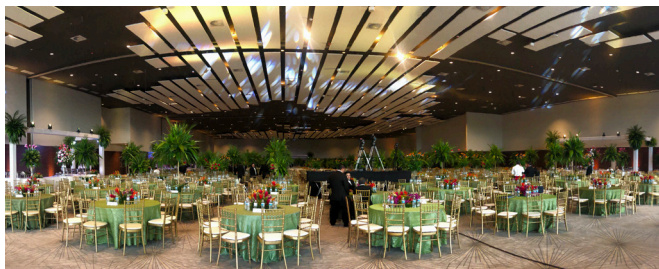

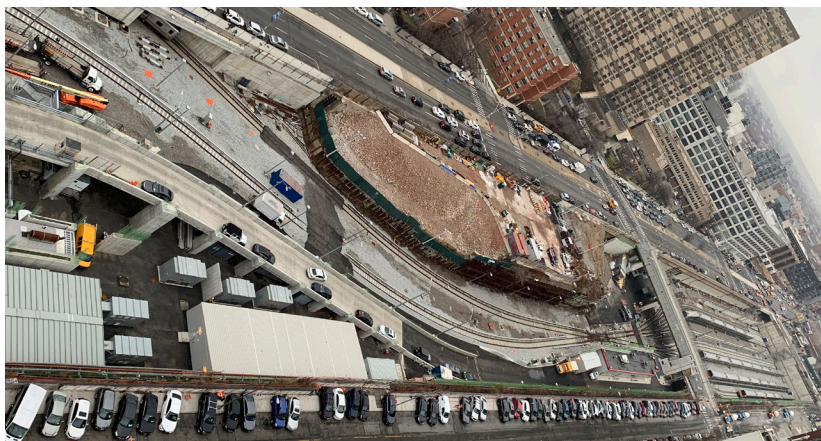

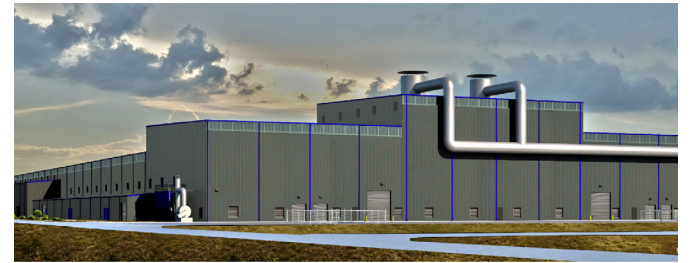
